In exercise of the power conferred under the Proviso to article 309 of the Constitution of India, the Governor of Bihar is hereby Pleased to make the following Rules amending "The Bihar Statistical service Rules 2009".


1. Short title, extent and Commencement: (1) These Rules may be called the Bihar Statistical service (amendment) Rules 2015.
(2) It shall extend to the whole of the State of Bihar.
(3) It shall come into force at once.
2. Amendment in Rule 5 of Bihar Statistical Service Rules 2009.

The following new sub rule (vi) will be added after sub rule (v) of Rule 5 of the said rules, 2009:-


(vi) Work weightage and relaxation in age limit for the District Statistical Officer/Assistant Director Candidates who have worked on contract Basis:-

- (a) Work weightage will be admissible of 5% (maximum up to 25%) marks for every full year to the District Statistical Officer/Assistant Director candidates working on Contract basis. This weightage will be admissible to the candidates for the main examination & interview of the commissions to be conducted in future.
- (b) Age relaxation of 5 years in maximum age limit will be given to those candidates who has worked as contractual District Statistical Officer/Assistant Director candidates of all categories.




